CITY CHARTER AMENDMENT NO. 1

CITY OF SEVIERVILLE CHARTER AMENDMENT SUBMITTED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF SEVIERVILLE PERTAINING TO THE ELECTION OF ALDERMEN:

SHALL ARTICLE IV, SECTION 1 OF THE CHARTER OF THE CITY OF SEVIERVILLE BE AMENDED BY ADDING A SECOND PARAGRAPH, STATING THAT BEGINNING WITH THE GENERAL CITY ELECTION HELD IN MAY 2017, THE TWO ALDERMANIC POSTS UP FOR ELECTION SHALL BE DESIGNATED SEAT 2 AND SEAT 4, THAT THE ALDERMANIC POSTS UP FOR ELECTION IN MAY 2019 WILL BE DESIGNATED SEAT 1, SEAT 3, AND SEAT 5, THAT ANY ALDERMANIC CANDIDATE SHALL DESIGNATE THE PARTICULAR SEAT THAT THE CANDIDATE SEEKS, ACCORDING TO THE REQUIREMENTS OF GENERAL STATE LAW; THAT IN THE GENERAL CITY ELECTION, ALL VOTERS MAY VOTE FOR ONE (1) CANDIDATE FOR EACH DESIGNATED SEAT; AND THAT THE CANDIDATE FOR EACH DESIGNATED SEAT RECEIVING THE MOST VOTES SHALL BE DECLARED ELECTED?
